The cancellation fee will be deducted from the refund amount. No refunds are issued if the participant withdraws after the first game day.

<u>Wait List:</u> A participant who registers after the registration deadline will be added to the wait list and is not guaranteed a place on a team. The Wait List will not be available after the first game day and registrations will no longer be accepted. If a participant on the Wait List is added to a roster, the registration dues and late fee must be paid before the first game is played and a team shirt can be ordered.
